Rules to be followed by students

- Students shall refrain from all activities considered as ragging which is a criminal offence.
- Students shall not deface, disfigure, damage or destroy or cause any loss in any manner to school property.
- Unauthorized entry of outsiders into the campus is strictly prohibited. Without specific permission authorities, students shall not bring or call outsiders to the school or outside the school campus.

Disciplinary Action

Suspension

A student may be suspended from the school for violation of any of the above rules. The Period of suspension and condition, if any, shall be clearly indicated in the communication addressed to the student shall lose his/her attendance for the suspended period.

Expulsion

This is the extreme form of disciplinary action and shall be resorted to only in cases where stringent action warranted. Expulsion is the permanent dismissal of a student from the institute. Such a student will not be eligible for readmission.
