The point wise reply of the discrepancies highlighted is as under:

1. It is submitted that all staff salary is being paid by Bank advice as school accounts and employees accounts are in the same Bank. The copy of Advices are enclosed as per Appx 'A'
2. It is submitted that we already applied for permanent affiliation and fee for permanent affiliation has already been paid. As per your office instructions we have applied for provisional affiliation till the finalization of permanent affiliation. However, DD bearing No 043546 dated 19-1-2015 for Rs. 50,000/- is enclosed.
3. It is submitted that more trained and qualified PRT/TGT teachers have been appointed as per section teacher ratio. The list of teachers is enclosed as per appendix 'B'

4. The section teacher ratio has been maintained as per Section ratio of 1:1.5 .

Aided up to 10th class as per sanctioned strength of the Aided staff CPF is being deducted and deposited in bank as per U.T Administration, Chandigarh directions and other unaided staff PF is being deducted and the latest EPF challan copy of Jan 2015 is enclosed as per appendix 'C'
